**CONSTRUCTION OF STANDARD MULTI-PURPOSE BUILDING
AT BARANGAY PARAISO, KORONADAL CITY**

1. The Commission On Audit Regional Office No. XII (COA RO-XII) through the Government of the Philippines intends to apply the sum of Ten Million Six Hundred Sixty-two Thousand Two Hundred Seventy-eight Thousand Pesos & 1/100 (P10,662,278.01) being the Approved Budget for the Contract (ABC) to payments under the contract for Construction of Standard Multi-purpose Building at COA Regional Office XII, Barangay Paraiso, Koronadal City. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The COA RO-XII now invites bids for Construction of Standard Multi-purpose Building at COA Regional Office XII, Barangay Paraiso, Koronadal City. Completion of the Works is required within 240 calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from COA RO-XII and inspect the Bidding Documents at the address given below from 8:00 AM – 5:00 PM, Monday to Friday.

A complete set of Bidding Documents may be acquired by interested bidders on April 17 to May 9, 2017 from the address abovementioned and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Ten Thousand Pesos (P10,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The COA RO-XII will hold a Pre-Bid Conference on April 26, 2017 (10:00AM) at 3F Conference Room, Commission On Audit Regional Office No. XII, Barangay Paraiso, Koronadal City which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before May 10, 2017 (1:30PM). All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.
