RESOLUTION NO. 2021-034
Series of 2021

WHEREAS, the Commission on Audit, through its Bids and Awards Committee (BAC), published an Invitation to Bid from April 29, 2021 to May 19, 2021 for the bidding of the project: Supply and Delivery of ICT Equipment (IB No. G-2021-01 with an Approved Budget for the Contract (ABC) of Two Million Five Hundred Twenty-Nine Thousand Five Hundred Pesos (P2,529,500.00);

WHEREAS, the deadline for the submission/receipt of bids was 9:00 a.m. of May 19, 2021 at the COA Regional Office No. VIII, Candahug, Palo, Leyte;

WHEREAS, only one bidder, the Joebz Computer Sales Services (Joebz for brevity), submitted its bid, and immediately thereafter, the opening of bids was conducted wherein Joebz passed the preliminary evaluation of the technical and financial components of the bid;

WHEREAS, the financial bid of **Joebz** showed the following:

ABC	Bid Amount (As Read)	% Variance from the ABC
P2,529,500.00	P2,461,544.17	(2.69%)

WHEREAS, the bid of Joebz underwent Detailed Bid Evaluation by the Technical Working Group (TWG);

WHEREAS, the TWG Report on Detailed Bid Evaluation dated May 25, 2021 showed a Calculated Bid of P4,542,106.75 which is higher than the ABC;

WHEREAS, after the deliberation by the BAC on the Report on Detailed Bid Evaluation, the bid of Joebz was declared as non-responsive/ineligible;

WHEREAS, Section 35.1, Rule 10 of the RIRR of RA 9184 provides that the BAC shall declare a failure of bidding when all prospective bidders are declared ineligible, among others.

NOW THEREFORE, the BAC resolves as it does hereby resolve to declare a **FAILURE OF BIDDING** for the Supply and Delivery of ICT Equipment.

RESOLVED FINALLY that a copy of this Resolution be furnished to the Head of the Procuring Entity, the Regional Director, COA Regional Office No. VIII, Candahug, Palo, Leyte, and shall be made an integral part of the procurement documents.
