RESOLUTION DECLARING THE BID OF UNICENTER COMMUNICATIONS AS THE SINGLE CALCULATED BID FOR LOT 1 AND RESORTING TO NEGOTIATED PROCUREMENT UNDER TWO FAILED BIDDINGS FOR LOT 2, FOR THE PROCUREMENT OF INFORMATION AND COMMUNICATION TECHNOLOGY EQUIPMENT (RE-BIDDING)

WHEREAS, the Bids and Awards Committee, after due posting, conducted the Opening of Bids for the project Procurement of Information and Communication Technology Equipment (Re-Bidding) on 01 June 2021 at 9:30 in the morning at the Ground Floor (Left Wing), Commission on Audit Regional Office XII, Barangay Paraiso, Koronadal City, South Cotabato;

WHEREAS, the above-mentioned Project consists of two (2) Lots with Approved Budget for the Contract as follows: Lot 1 – Two Million Two Hundred Eight Two Thousand Nine Hundred Ninety Two Pesos (P2,282,992.00); and Lot 2 – Six Hundred Sixty Two Thousand Eight Pesos (P662,008.00);

WHEREAS, only one (1) prospective bidder purchased the Bidding Documents for this Project, Unicenter Communications, Davao City;

WHEREAS, during the above Opening of Bids, one (1) bid from Unicenter Communications was duly received and opened by the BAC for Lots 1 and 2, and whose authorized representative was also present thereat;

WHEREAS, upon preliminary examination of Bids pursuant to Section 30.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, otherwise known as the Government Procurement Reform Act, the BAC has found and established that the Bid submitted by Unicenter Communications is compliant with the eligibility and technical requirements prescribed by the Procuring Entity;

WHEREAS, upon opening of the second envelope containing the financial proposal of Unicenter Communications, it was determined that the bid were as follows:

Lot No.	Bid Amount	ABC
1	P2,276,910.00	P2,282,992.00
2	P665,450.00	P662,008.00

WHEREAS, the second bidding for Lot 2 resulted to another failure since the bid of Unicenter Communications for Lot 2 was disqualified outright during bid opening since their bid is higher than the ABC, thus, Negotiated Procurement under Two Failed Biddings may be resorted pursuant to Section 53.1 of RA No. 9184 and its 2016 IRR;

WHEREAS, pursuant to Section 32.2 of the 2016 Revised IRR, the BAC conducted detailed evaluation of the financial component of the bid submitted by Unicenter Communications for Lot 1 to determine its completeness and computational correctness;


WHEREAS, after thorough evaluation, it was determined that the bid of Unicenter Communications was rated as the Single Calculated Bid for Lot 1 in the amount of Two Million Two Hundred Seventy-Six Thousand Nine Hundred Ten Pesos (P2,276,910.00);


