**INVITATION TO BID FOR THE PROCUREMENT OF
INFORMATION AND COMMUNICATION TECHNOLOGY
EQUIPMENT**

1. The COMMISSION ON AUDIT REGIONAL OFFICE NO. XI, through the Regular Agency Fund (RAF) of CY 2021, intends to apply the sum of TWO MILLION SEVEN HUNDRED EIGHT THOUSAND FIVE HUNDRED PESOS (Php 2,708,500.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the following lots;

Lot 1 ABC P2,235,000.00

Lot 2 ABC P 400,000.00

Lot 3 ABC P 73,500.00

for Procurement of Information and Communication Technology (ICT) Equipment. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The Commission on Audit Regional Office No. XI now invites bids for the above Procurement Project. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Prospective Bidders may obtain further information from the Commission on Audit and inspect the Bidding Documents at the given address during office hours from 8:30 AM to 3:00 PM.
5. A complete set of Bidding Documents may be acquired by interested Bidders on June 7, 2021 until the deadline for the submission of bids, from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents pursuant to the latest Guidelines issued by the GPPB, in the amount of P2,300.00 for lot 1; P500.00 for Lot 2 and P200.00 for Lot 3. The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person, by facsimile, or through electronic means.
6. The Commission on Audit Regional Office No. XI will hold a Pre-Bid Conference on June 15, 2021, 9:30 A.M. at the COA Regional Office No. XI, C.P. Garcia National Road,

Buhangin, Davao City which shall be open to prospective bidders. Those bidders interested to participate via zoom shall register with the BAC Secretariat for the zoom link through email address indicated below.

7. Bids must be duly received by the BAC Secretariat through manual submission at the given address as indicated below on or before June 28, 2021, 12:00 noon (biometric clock located at COA ROXI lobby). Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
9. Bid opening shall be on June 28, 2021, 1:30 P.M. at the COA Regional Office No. XI, C. P. Garcia National Road, Buhangin, Davao City. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity or witness the opening of the bids through video conferencing via zoom. Those bidders interested to participate via zoom shall register with the BAC Secretariat for the zoom link through email address indicated below.
10. The Commission on Audit Regional Office No. XI reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
